What's New?

- CMS began using star ratings to publicly report the ICH CAHPS quality measures that are published on the Dialysis Facility Compare (DFC) in October 2018.

- The 2017 Spring and 2017 Fall National and State
 Averages were posted on the ICH CAHPS website on
 10/26/2018 and can be found at the ICH CAHPS

- Guidance on contacting and handling ICH CAHPS sample patients at nursing homes, including an updated mail questionnaire and telephone script, was posted on 9/19/18. The updated mail survey and telephone script must be used starting with the 2019 Spring Surveys, if not already implemented for 2018 Fall. - As of October 2018, ICH CAHPS no longer requires the submission of hardcopy ICH Facility Survey
 Administrator (SA) Consent Forms. Designated ICH CAHPS Facility SAs will now submit an online SA consent form as a part of the online CCN registration process. More information on this process can be found in the ICH CAHPS Survey Administration and Specifications Manual, Version 7.0 (to be posted in February 2019).

A Technical Assistance Inquiry

Q: What is the Facility Non-Participation Form (NPF) and does it impact QIP compliance?

A: ICH facilities that have determined that they are not required to participate in the ICH CAHPS surveys because of low patient census are required to submit an NPF on the ICH CAHPS website. Facilities can determine if they are required to participate at the ICH CAHPS website C. The NPF is available on the ICH CAHPS website at the beginning of each calendar year and is valid only for the year in which it was submitted. The NPF alerts the ICH CAHPS CT to not provide a sample to a vendor for the surveys during the calendar year the NPF was submitted. This form is different than the attestation in CROWNWeb (CW). QIP does not use the NPF to inform compliance. If you have specific questions about attestation in CW or QIP compliance in general, please contact the QIP team.



Star Ratings on DFC

ICH CAHPS star ratings use a 5-star scale that makes it easier for consumers to compare ICH facilities. More stars mean better quality care. Star ratings are calculated for each of the three publicly reported global ratings, each of the three composites, and an overall summary star. The table below provides an example to show how the summary star is calculated:
