New staff from approved survey vendors are strongly encouraged to complete the self-paced Intro training. No certification is required for approved vendors.

### 2024 ICH CAHPS Participation Requirements: ESRD PPS Rules

- Requirements for administering the ICH CAHPS Survey are determined by the End Stage Renal Disease (ESRD) Prospective Payment System (PPS) proposed and final rules for each calendar year.
- The final ESRD PPS Rule for CY2024 was published on November 6, 2023.
  - The 2024 surveys are part of the quality reporting requirements for payment year 2026.

### 2024 ICH CAHPS Participation Requirements: Determining Participation

• ICH facilities must determine whether they are required to administer the ICH CAHPS Surveys in CY2024 by counting the number of survey-eligible patients served in CY2023.

IF...the facility served **30 or more** survey-eligible patients in CY2023, then:

Facility **IS** required to contract with an approved ICH CAHPS Survey vendor to administer the surveys in CY2024.

IF...the facility served **29 or fewer** survey-eligible
patients in CY2023, then:

Facility **is NOT** required to participate in the ICH CAHPS Surveys in CY2024 but can do so if it chooses.



# 2024 ICH CAHPS Participation Requirements: Determining Participation (cont'd)

When determining whether an ICH facility is required to participate in the ICH CAHPS Survey in CY2024, the facility should count the number of surveyeligible patients the facility served in CY2023. The count should include hemodialysis patients who:

Were 18 years old or older as of December 31, 2023;

Were alive as of December 31, 2023;

Received hemodialysis on an outpatient basis from their facility for 3 consecutive months or longer at some point in CY2023;

Are not currently receiving hospice care;

Were not receiving dialysis care at a nursing home or other skilled nursing facility where they lived (as opposed to traveling to an ICH facility); and


Were not living in a long-term facility such as a prison or jail as of December 31, 2023.

# 2024 ICH CAHPS Participation Requirements: Participation Steps in the 2024 ICH CAHPS Survey Facility Administered the Survey in a Preceding Survey Period

Facilities that authorized a vendor between 2014 and 2023 do not need to update their vendor authorization UNLESS one of the following is true:

They are switching to a different survey vendor.

They entered an End Date prior to 2024 on their Vendor Authorization Form.

They submitted a Facility Non-Participation Form in the previous survey period.

#### # Activity

- Select and contract with a CMS-approved ICH CAHPS survey vendor.
- Designate a Survey Administrator who will create login credentials on the ICH CAHPS website.
- 3 Register the CCN(s) on the ICH CAHPS website.
- 4 Complete the online "Authorize a Vendor" form on the ICH CAHPS website (only after the facility and vendor have a written contract in place).
- 5 Check the ICH CAHPS website regularly for news and updates.
- **6** Assign backup administrators on the ICH CAHPS website.



# 2024 ICH CAHPS Participation Requirements: Participation Steps in the 2024 ICH CAHPS Survey Facility is Not required to Administer the Survey

ICH facilities that are **not** required to administer the survey in 2024 can choose one of the following options:

#	Facility Participation Options	Vendor Receives a Sample File from CMS?	Vendor Submits Data to the Data Center for Public Reporting?
1	Administer both surveys in 2024 following all the ICH protocols and procedures described in the ICH CAHPS Survey Administration and Specifications Manual.	Yes	Yes
2	Administer the survey using a third-party vendor but not following the ICH CAHPS protocols and procedures.	No	No
3	Administer the survey themselves instead of using a third-party vendor.	No	No
4	Choose not to administer the survey at all.	No	No

# 2024 ICH CAHPS Participation Requirements: The 2024 Facility Non-Participation Form

Vendors should note the following details regarding the Facility Non-Participation Form: The Facility Non-Participation Form is an annual form that is valid only for the two data collection periods that occur in the calendar year in which the form was submitted.

Submission of the Facility Non-Participation Form only alerts the ICH CAHPS Coordination Team that the facility does not wish for a sample file to be provided to their authorized vendor for the current calendar year; it does not affect compliance.

Once the Facility Non-Participation Form is submitted, any existing vendor authorization for the submitted CCN(s) is removed from the ICH CAHPS website. If participating in the survey in subsequent years, the Survey Administrator will need to authorize a survey vendor for the CCN(s).

The Survey Vendor Authorization Report (accessible via the vendor's dashboard) will indicate whether a Facility Non-Participation Form has been submitted for any CCN listed on the report.

The Facility Non-Participation Form is different than the attestation a facility submits in EQRS at the beginning of each year to attest to CMS that the facility served 29 or fewer survey-eligible patients during the preceding calendar year.

# Other Facility Non-Participation Form Reminders:

If a facility has an alternate CCN currently registered on the ICH CAHPS website, the facility should submit the Facility Non-Participation Form for both the primary and alternate CCNs.

The 2024 Facility Non-Participation Form must be submitted by 5:00 PM ET on February 28, 2024.

- In CY2024, the Thanksgiving holiday falls on 11/28/24.
- Because some vendors may have difficulties with the original data collection deadline set in the last week of November, vendors may instead start the 2024 Fall second wave of ICH CAHPS data collection activities on 12/4/24 instead of the original 11/29/24 start date, if they choose to do so.



### Sampling: Vendor Authorization Issues

#### When to notify the Coordination Team of facility authorization issues that impact a survey vendor's ability to receive the sample file:

Once the February 28, 2024 deadlines to authorize a vendor, submit a Facility Non-Participation Form, and submit a Vendor Facility Closing Attestation Form have passed, vendors should notify the Coordination Team immediately of any discrepancies with their expected list of CCNs on the ICH CAHPS website.

Vendors must notify the Coordination Team by **March 1, 2024**, for the 2024 Spring Survey and **September 1, 2024**, for the 2024 Fall Survey if any contracted CCNs are missing from their Vendor Authorization Report and the CCN does not appear on the Facility Non-Participation Form Report or Vendor Facility Closing Attestation Report.



# Sampling: Updated Protocol for Facilities that have Primary/Alternate CCN Pairs

- In the past, facilities were encouraged to register and authorize a vendor on the ICH CAHPS website for all CCNs related to a single facility; these CCNs are referred to as primary/alternate CCN pairs.
- If sample patients appeared under both CCNs in CROWNWeb, the Coordination Team sampled patients under both CCNs then combined the results for public reporting under what the Care Compare team considered the "primary" CCN.
- With EQRS, data can only be entered for a facility under <u>one</u> CCN.



# Sampling: Updated Protocol for Facilities that have Primary/Alternate CCN Pairs (cont'd)

Facilities that are registering/authorizing a CCN for the first time on the website moving forward



Facilities should only register and authorize a vendor for one CCN per facility. This should be the CCN that data is reported under in EQRS.

Facilities that already have multiple CCNs registered/authorized for a facility on the website



No action is needed if a facility already has a primary/alternate CCN pair registered/authorized.

Alternate CCNs will appear to have 0 sampled patients on the Sample File Summary Report, as all sampled patients will appear under the "primary" CCN.



#### Sampling: Seeded Mailing Protocol

Using the wrong version of letters provided.

Incorrect formatting (italicizing, underlining, bolding, spacing).

Common Issues Found During Seeded Mailing Review

Editing the official envelope without an approved ERF.

Incorrect vendor information included in letters.





# Survey Administration: Updates to Minimum Business Requirements

 Update: The ICH CAHPS minimum business requirements (MBRs) now reflect that CMS may permit home-based or virtual interviewers or mail survey staff to administer the ICH CAHPS survey. An Exceptions Request Form (ERF) must be submitted and approved by CMS prior to administering the survey using virtual staff.

# Survey Administration: New Protocol for Handling Requests for Alternate Formats/Modes of the ICH CAHPS Survey

 Should an ICH CAHPS Survey Vendor receive a request from a sample patient to receive/complete the survey in an alternate format or mode due to an accessibility issue, the vendor is asked to contact the Coordination Team for guidance on how to proceed.

### Examples of requests vendors may receive are listed below:

Requests for vendors to provide a large-print questionnaire due to a vision disability;

Requests for mail-only vendors to conduct the survey over the phone for a blind respondent; or

Requests for phone-only vendors to send a mail survey to a deaf or hard-of-hearing respondent.

# Survey Administration: Revised XML Data Layout File and Schema Validation Tool for Data Submission

The ICH CAHPS Survey XML data layout file (Version 9.0) has been revised to reflect the edits made to Q59 in the mail surveys, and Q59 and Q59b in the telephone scripts for 2024 Spring. These XML file edits include:

Reordering of the race response options for XML element Q59-mail, Q59-phone, and Q59b-phone to match the new order of the response categories for these survey questions (i.e., alphabetical order).

The addition of the following two race variables:

- Q59-mail <race-asian-mail> (i.e., "Asian");
- Q59-mail < race-native hawaiian pacific-mail > (i.e., "Native Hawaiian or Pacific Islander").

By May 2024, the ICH CAHPS Survey data submission tools (Schema Validation Tool and Data Submission Tool) will be updated to reflect the edits made to Q59 and Q59b.

Announcements will be posted on the website when the revised tools are available.

If not implemented correctly, XML files will fail data submission validation checks.

#### **ICH CAHPS Facility Survey Administrator Consent Form**

• Revised to inform the designated Survey Administrator that their contact information will be provided to the survey vendor they authorize for their CCN(s).

#### **ICH CAHPS Automated Email Messages**

- Vendor/Facility user automated messages revised to reflect new ICH CAHPS protocol regarding handling primary and alternate CCN pairs.
  - (i.e., Facilities no longer need to register and authorize multiple CCNs for a facility on the ICH CAHPS website (but should ensure the CCN that they enter data under in EQRS is the CCN that is registered and authorized on the ICH CAHPS website).
- Language added to Vendor Authorization confirmation email that the currently registered ICH Facility Survey Administrator's contact information can be found on the Vendor Authorization Report.
- Language added to facility's vendor authorization conformation email that their contact information will be shared with their authorized vendor.
- Additional minor edits for better readability.

# Survey Administration: Change to Survey Vendor Authorization Report

- The Survey Vendor Authorization Report (accessible via the vendor's dashboard), has been revised to include the facility's currently registered\* ICH CAHPS Survey Administrator's contact information (name, telephone number, and email address), once the authorization form is submitted by the facility.
- Report can now be filtered to show expired authorizations.

#### **Vendor Oversight: ICH CAHPS Site Visits**

Site visits may be conducted virtually or as an offsite site "visit."

A total of 72 ICH CAHPS site visits have been conducted to date.

The purpose of a site visit is to ensure that approved vendors are operating in compliance with ICH CAHPS Survey protocols.

The next site visits are scheduled to take place in May and June 2024.

Site visits are coordinated across all CMS CAHPS Surveys.



#### Vendor Oversight: ICH CAHPS Site Visits (cont'd)

#### Data Digging and Call History Review Protocol Change

- This activity will be conducted, and results sent to vendors, prior to site visits.
- Data digging requests will be made by the Coordination Team earlier in the site visit process.

#### Goal of Protocol Change

 Allow time for vendors to conduct internal investigations, if needed, so that findings can be discussed during the virtual site visits.



### Vendor Oversight: Common Issue Found During 2023 Site Visits

Only one common issue among vendors conducting ICH CAHPS telephone surveys during 2023 site visits:

Vendors who conduct ICH CAHPS telephone surveys should conduct reminder trainings on various interviewing techniques and protocols, such as:

- Reading Verbatim
- Clarification Probing



#### Vendor Oversight: Quality Assurance Plan

### Annual Quality Assurance Plan Update Submission Due Date: May 31, 2024

Survey vendors are required to include the following in their QAP Update (or as an attachment):

Copy of the mail survey (for mail and mixed mode surveys) for each language they are administering the survey;

Screenshots of the entire survey from their CATI interview (for telephone and mixed mode surveys) for English and Spanish, if applicable;

Cover letters 1 and 2 for each language they are administering the survey; and

Screenshot of their ICH CAHPS Survey package envelope template (used to send both prenotification letters and mail survey packages).

# Vendor Oversight: Revised Remote Work ERFs for 2024 Spring

- CMS has implemented a policy that vendors must update their remote work ERFs every two years, or when any changes are made to the approved remote work protocol.
- If you have approval to conduct remote work on the ICH CAHPS Survey,
   CMS requests that you submit an extension to renew this approval, using a new form, prior to the 2024 Spring Survey period (mid-February).

#### **Next Steps:**

- The Coordination Team will reach out to follow-up on this request directly.
- Vendors will be required to submit an extension after 2 years.

Code 210 (Breakoff):

• Should be assigned if the sample patient responds to some questions but not enough to meet completeness criteria.


Code 190 (Ineligible: No Longer Receiving Care at Sampled Facility):

 Should be assigned if telephone and the response to Q1 or Q2 is DK/RE.

#### Clarification Regarding Code 130 - Completed Mail Survey; Eligibility Unknown





### Data Processing and Coding: Clarifications for Assigning Code 210

#### Clarification Regarding Code 210 - Breakoff

A Code 210 should be assigned if: The respondent answers some questions but not enough to meet completeness criteria **AND/OR** 

The case does not meet any other coding criteria.



#### Data Processing and Coding: Code Assignment Clarification


Vendors should **NOT** assign final disposition codes based on the results from commercial address and/or telephone database service or directory assistance verifications.




### Respondent Education Distribution 2022 Fall and 2023 Spring






### Respondent Age Distribution 2022 Fall and 2023 Spring






### Respondent Gender Distribution 2022 Fall and 2023 Spring






### Respondent Language Spoken at Home 2022 Fall and 2023 Spring






### Respondent Self-Reported Overall Health 2022 Fall and 2023 Spring



#### Purpose of Mode Experiment



To test a shorter ICH CAHPS Survey, to improve patient burden.



To test the feasibility of implementing a web mode with the ICH CAHPS population.



#### What does the revised ICH CAHPS Survey look like?

22 questions removed from the mail survey

21 questions removed from the telephone survey

Current: 62 questions

Current: 59 questions

Revised: 40 questions

Revised: 38 questions



#### **Mode Experiment Modes**

Mail-only

Telephoneonly Mail with telephone follow-up (mixed mode)

Web with mail followup



- Analyzed data (patient-mix adjustment, non-response bias, mode effects, and psychometric measures) and submitted final report to CMS.
  - Analyses supports the shorter survey.
  - Analysis not conclusive for web-based mode due to lack of email addresses/web responses.
- Presented the results to a Technical Expert Panel.
  - Agreed that should move forward with shorter survey.
  - Emphasized that a web-based mode is necessary for this survey.
- Presented the results to the CAHPS Consortium.
  - Asked for additional analysis to possibly remove one other question before moving forward with the approval process.



#### **Next Steps:**

- Conduct additional analysis to determine if one other question can be removed from a psychometric perspective.
  - If question can be removed, reach out to TEP members to ensure they are okay with this removal.
- Move forward with necessary approvals, including:
  - Final rule for the End-Stage Renal Disease (ESRD) Prospective Payment System (PPS)
  - Partnership for Quality Measurement (PQM) endorsement, and
  - Office of Management and Budget (OMB) approval.
- At this time, the timeline is uncertain, but we will keep vendors and facilities updated on approval progress.
